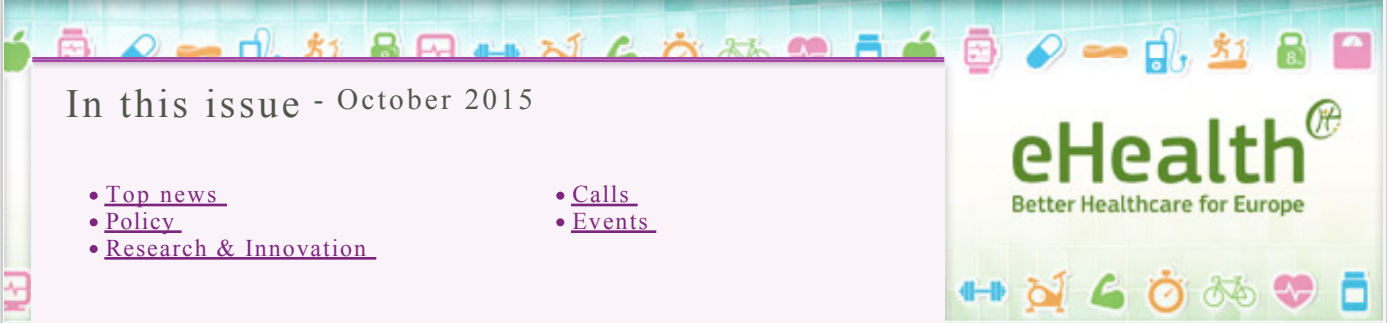

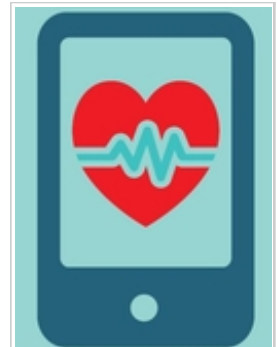

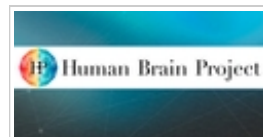

### FUSIMO: Advanced technology for non-invasive cancer treatment

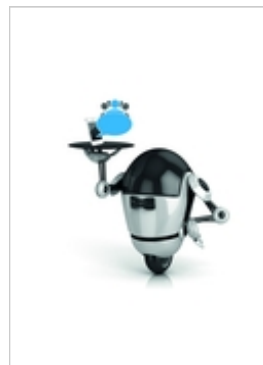
